The above temporary extension of affiliation shall be subject to the following terms and conditions:

- 1. Four (04) more teaching staff should be appointed for the existing Courses
- 2. Ratification of the Principal and faculty members be completed at the earliest.
- 3. Prof. Y. Madhusudan Rao, Director, whose age is more than 70 years is not eligible to work as a Faculty member /Principal/ Director.
- 4. In Society documents, the name of the President, who was expired long back was not changed.
- 5. The Laboratory facilities are not up to the Standards. The Labs do not have instruments such as FTIR, Fluidized bed drier, Lyophilizer, antibiotic zone reader, and most of microscopes are not in a working condition.
- 6. No power backup for the Labs.
- 7. The Computer Lab needs to be updated with latest software that supports English language software and Experimental Pharmacology Software.
- 8. Elevator need to be installed...
- 9. Genuinity certificates of Ph.D. holders should be submitted from the respective Universities.
- 10. Latest EC was not submitted
- 11. The Principal Office is not in a good condition.
- 12. Students Attendance Registers not produced
- 13. Salaries of the Teaching and Non-teaching staff should be paid through bank only.
- 14. Biometric attendance of Staff and Students should be maintained.
- 15. There is no barrier free environment for physically challenged persons.
- 16. The College Website was not updated.
- 17. In each Lab. Stock Registers, the account of chemicals and glassware are fabricated and a laboratory-specific log book was not kept in Labs.
- 18. Attendance Registers of Students, Teachers, Students Admission Registers, Salary Acquittance Registrar and Centralized Stock Register are not maintained properly.
- 19. The college has not subscribing any Journals during the last few academic years and also they are not keeping student issue registers in the Library, which indicates that no student movement in the Library. Library should be updated with new books & journals as per the syllabus.
